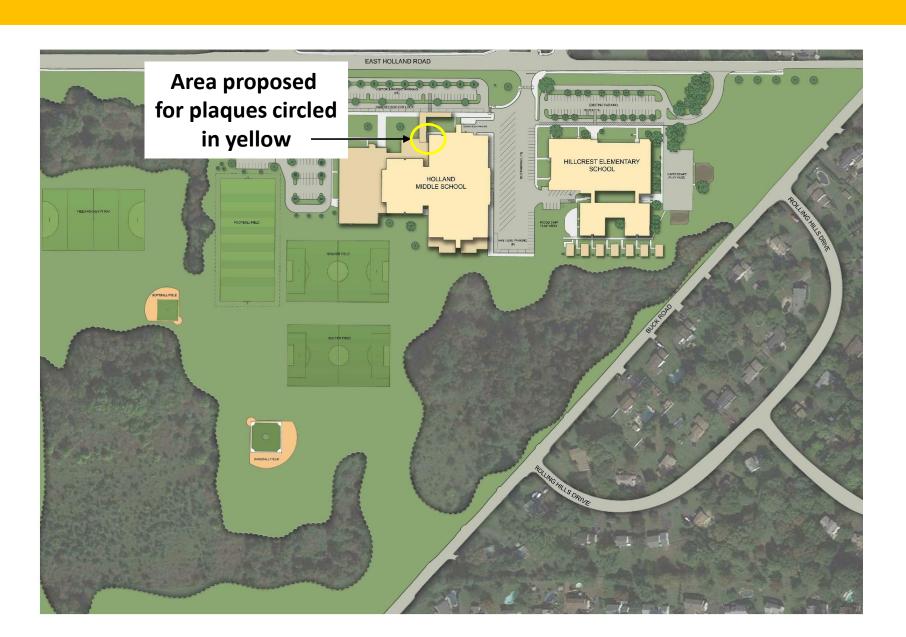

- High Schools have been excluded from the program for many years.
 - The restrictions of the foods able to be served in the program would reduce the participation beyond the amount of subsidies the District is forgoing.

Vendor Selection

- Chartwells had been our food service contractor for over twenty years.
- Every five years the District must go through a vendor selection process as prescribed by the NSLP. The last time we did this was in the 2014-2015 year.
- The 2018-2019 year is the last of the four renewals. We will be going through the vendor selection process in the Spring of 2019.

Board Direction

- High School Free and Reduced Lunch Reimbursement
 - "The cost of providing the free and reduced lunches at the high school will not be absorbed by the food service program. Donated USDA commodities cannot be used in meals prepared for the high school. Records for meals served, donated food used, cost of food, employee costs, etc. must be broken out for the High School and be separate from the other schools being served."

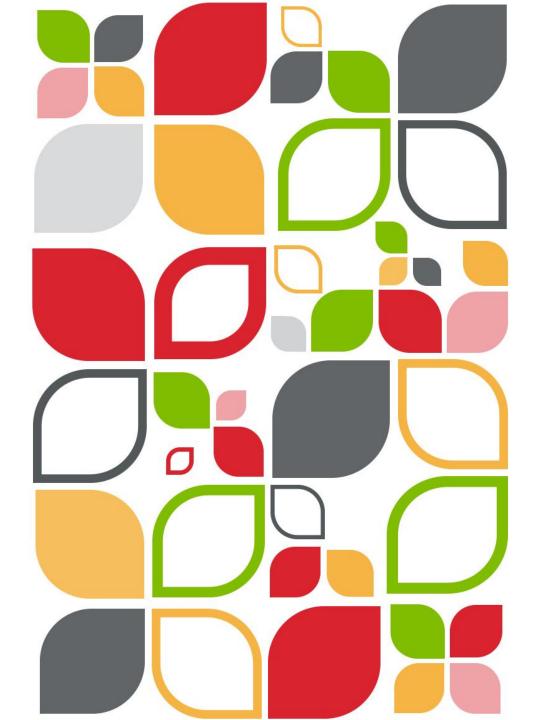

July/August 2017

Background

- 2014 Whole grain-rich (WGR) federal regulations take effect
- 2015 State agencies were first granted the flexibility to allow for exemptions towards WGR requirements
- 2017 USDA is continuing to offer districts flexibility through WGR waivers



Commitment to Nutrition

- Chartwells is committed to the highest nutrition standards
- Flexibility and variety are essential in offering a variety of foods that students enjoy
- Utilizing the whole grain waiver may help to:
 - increase participation
 - meet student preference
 - decrease food waste
 - increase food quality



Previous Successes

- 54 Chartwells K12 school districts granted whole grain waivers in SY16-17
- Case Study: Spartanburg, SC Enriched Biscuit –
 5% breakfast participation increase

Resources for Implementation

- State-Specific Waiver Application Resources and Instructions
- Sample completed waivers
- Communication tools when speaking with stakeholders
- Product sourcing, stocking, and recipes



Next Steps

- We would like to request a waiver for: pasta, pizza, biscuit, waffles, pancakes, bagels, and wraps
- Approval to begin the application process
- Meeting to review the application
- District submits the application to state agency



Board Direction

- Increase participation:
 - Withdraw the Middle Schools from the National School Lunch Program.
 - Serve more foods that are popular with the students to increase participation.
 - Structure the service more like the High School program.

Meal Charge Procedure/Unpaid Accounts

- We adopted a new Administrative Regulation Food Service Payment Procedures for Student Accounts last year.
- This procedure allows the District seek restitution for unpaid debt by putting a claim in through the Magistrate's Office
- Currently the negative balances amount to over \$15 thousand.
- State and Federal Requirements:
 - Prohibits schools from denying a school food program meal to any student who requests one but does not have money to pay for it.
 - Any attempt to collect the unpaid balances must be made to parents and not the student.
 - Prepare a local Meal Charge Procedure

Approval of Two Deputies for the Northampton Township Elected Tax Collector

- In February we received notice from Mr. Borkowski, the Northampton Township Tax Collector, that he wanted a former deputy removed and two deputies added.
- I am requesting the Board to authorize the deputies to collect our property and occupation assessment taxes.
- The Township and bonding company have already approved the appointments.

Discussion Item

Senate Bill 1099 – Alternative Tax Collections for Property Taxes

- The Bill allows the Board of School Directors to appoint a tax collector to collect our property and occupation assessment taxes.
- The person appointed will receive such compensation as agreed to with the Board.
- This appointment will occur at the end of a term or the vacancy of an elected tax collector.
